Sea Tow will not be held liable for any other towing company invoices or bills. Sea Tow must be used where coverage is available. It is also understood that Sea Tow International, Inc. or its licensees, organisations, agents, or employees will not be held responsible for damages or injuries occurring to member's vessels or passengers while engaged in any services rendered to its members. Members assume all risks of towing and all other services required in any case other than extreme negligence. In the event of any injury to persons aboard ship or any occurrences that threaten the safety of passengers or vessel, the applicant should immediately contact the Australian Coast Guard and request emergency assistance. Services will vary by area and by season. Sea Tow reserves the right to terminate or limit this membership for any abuses. Intoxicated parties may be refused service!
